

**SINCERELY, NEIGHBORS
SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT

**This Sweepstakes is governed exclusively by the laws of the United States. You are
